- Please provide the date on which these resolutions were adopted.
- Provide the official name of your Credit Union.
- Identify whether your Credit Union is established under State (specify which State) or U.S. law.
- Provide the complete address of your Credit Union's main office.
- Identify specific individuals who have the authority to execute and amend agreements with Millennium Corporate Credit Union on behalf of the Credit Union. It is not necessary to list all of the individuals who will be contacting or dealing with Millennium Corporate Credit Union but rather one or two individuals (i.e. President, Vice President, Board Chairman, etc.) who are authorized. Many of Millennium Corporate's services require authorization lists specific to that service.
