As more countries begin to open to U.S. visitors and your members **consider** and eventually **embrace** traveling abroad again, know that we're here to support their and your foreign currency needs!

The steps are easy-peasy pumpkin pie...



#### Order Foreign Currency

Call an Account Specialist - 800.721.2677, option 1. Share all the details by 1:00 PM CT for NEXT DAY DELIVERY!



#### Receive Foreign Currency

When you get it, be sure to give it the once over and review the Transaction Receipt along with the currency. The Total Due on the enclosed receipt will coincide with the amount debited from the credit union's settlement account. (The sender of the order is **CXI** or **Currency Exchange International**, our new FX currency partner.)



#### SPEND Foreign Currency!

Send your members off to explore the world with the **CURRENCY** and **CONFIDENCE** they need! *(This is by far the best step!)*

And, should those worldly members return with a bit of foreign cash, sell it back! Securely ship (certified mail) the extra to your preferred office (St. Louis or Wichita) along with the Foreign Currency Sell Request Form (conveniently found on the website and coreCONNECT) and, voila! (VOILA, in this instance, translates to- it will be bought back and processed, again, through your settlement account.) *Some details apply - see the Foreign Currency Sell Instructions & Request Form for processing details or speak with a Member Services team member at 800.721.2677, option 1.*

## CUleader In The House

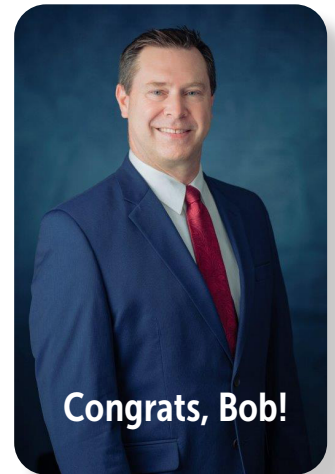
Robert Jewett, Member Engagement

## One Million Dollars Same-Day ACH Transaction Limit Increase

Same-Day ACH transactions are about to get a big bump! NACHA members approved a measure to increase the per-payment maximum from the current \$100,000 to \$1,000,000, effective March 18, 2022. The change applies to all eligible Same-Day ACH payments, including credits and debits for both businesses and consumers.
