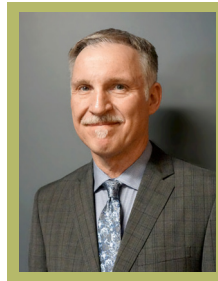

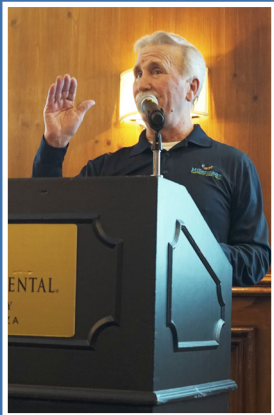
## LARRY EISENHAUER'S RETIREMENT RECEPTION
